## RE: CERTIFICATE OF LIABILITY INSURANCE

As you may know, as an Exhibitor participating in a show, it is recommended you have adequate Liability Insurance with a **minimum \$2,000,000** limit to protect the Exhibitors, the attending public, the show organizer and yourself. (Please note: Exhibitor Insurance is not mandatory.)

**Our insurance policy does not extend coverage to any exhibits and we are required by our Insurance Company and the Facility, that all of our Exhibitors provide us with a satisfactory Certificate of Insurance.**

There are two (2) ways to arrange the required insurance.

### **OPTION #1: With Nacora Insurance Brokers Ltd.**

*Note: Property excluded from coverage – EDP (Electronic Data Processing), audio & video equipment, watches, jewellery made of precious or semi precious stones and/or precious metals, money, bullion, securities, stamps, antiques, furs, and fine arts valued at \$5,000 per item or greater.*

**\$2,000,000** Comprehensive General Liability – Bodily injury and Property Damage Liability, Subject to \$1,000 BI & PD Ded – Inclusive each occurrence –Products and Completed Operations Liability \$2,000,000 annual aggregate, Employees as additional insured's, Contingent Employers Liability, Broad Form Property Damage, , Cross Liability Clause, Severability of Interest Clause.

**\$100,000** Tenants Legal Liability – Broad Form

- **Coverage is subject to:** Asbestos Exclusion, Mold Fungi Exclusion, Data, War, Nuclear, Property flood and earthquake exclusion. Territory Restriction – Canada.
